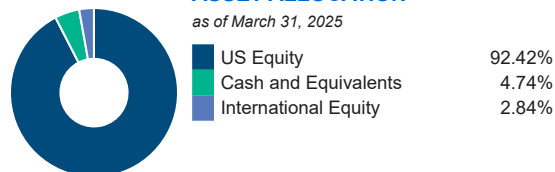

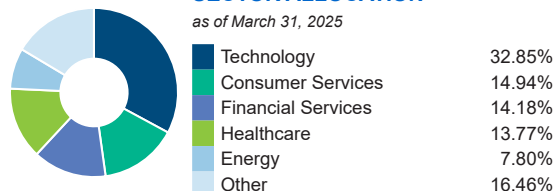
## ASSET ALLOCATION

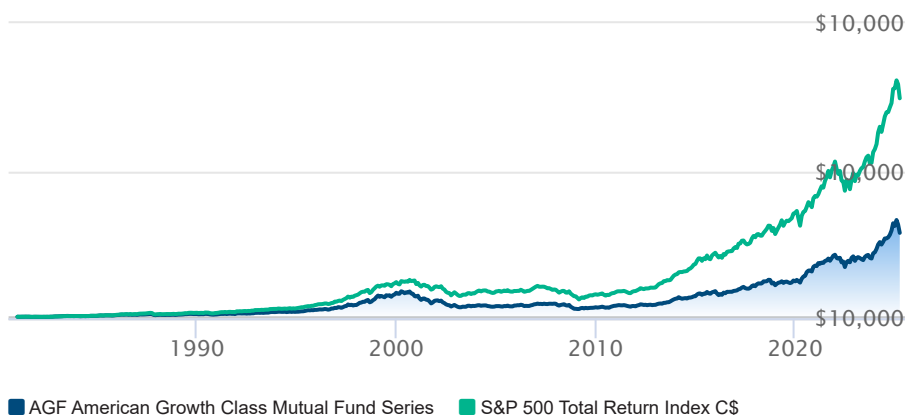
