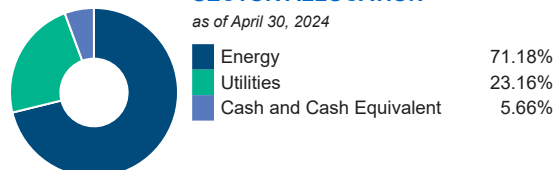
## ASSET ALLOCATION

as of April 30, 2024



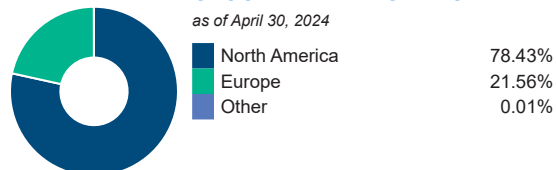
## SECTOR ALLOCATION
