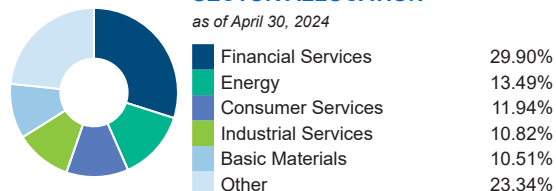
ASSET ALLOCATION
