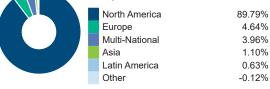
SECTOR ALLOCATION

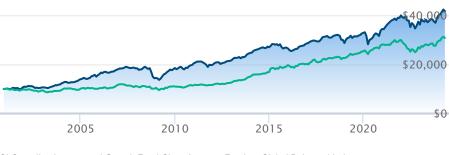
