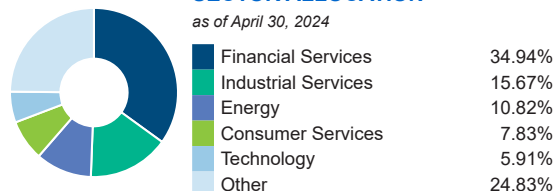
## ASSET ALLOCATION
