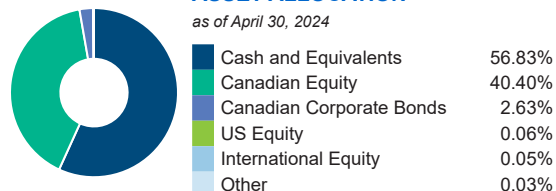

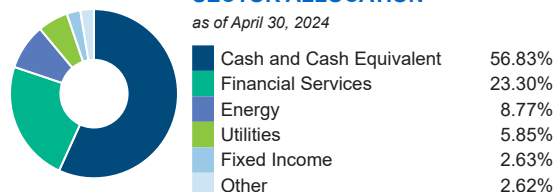
ASSET ALLOCATION
