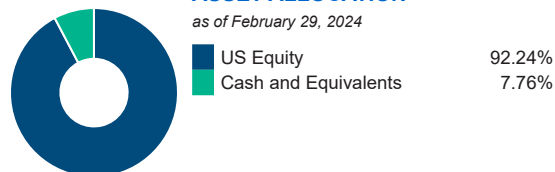

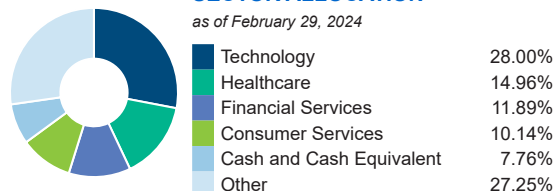
ASSET ALLOCATION

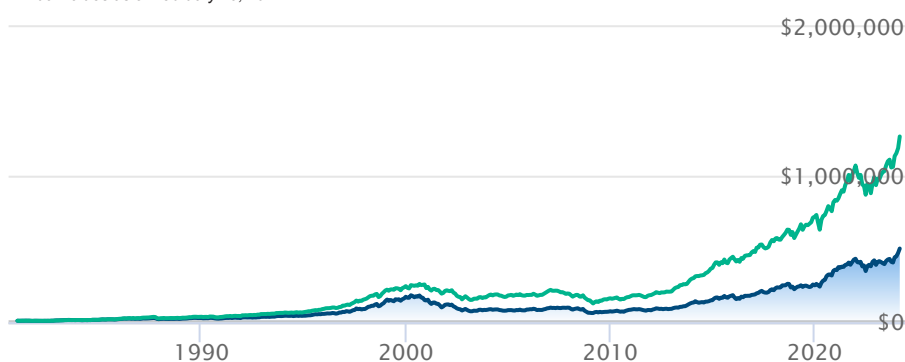
