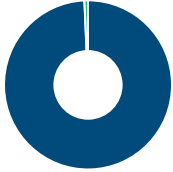

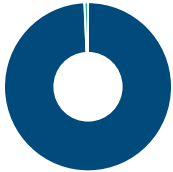

SECTOR ALLOCATION

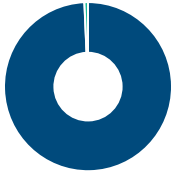

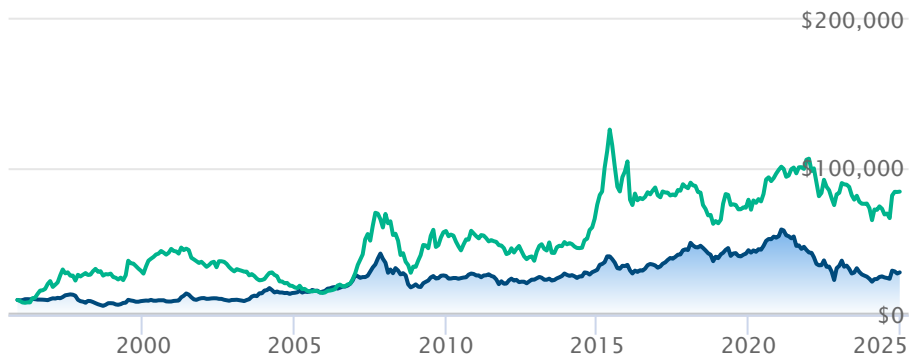
