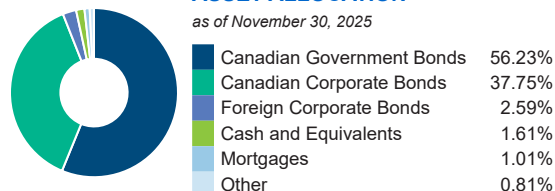

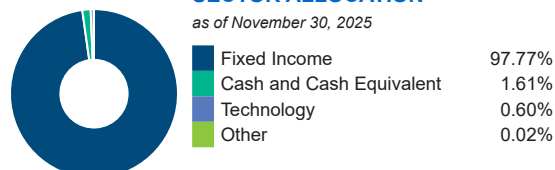
ASSET ALLOCATION

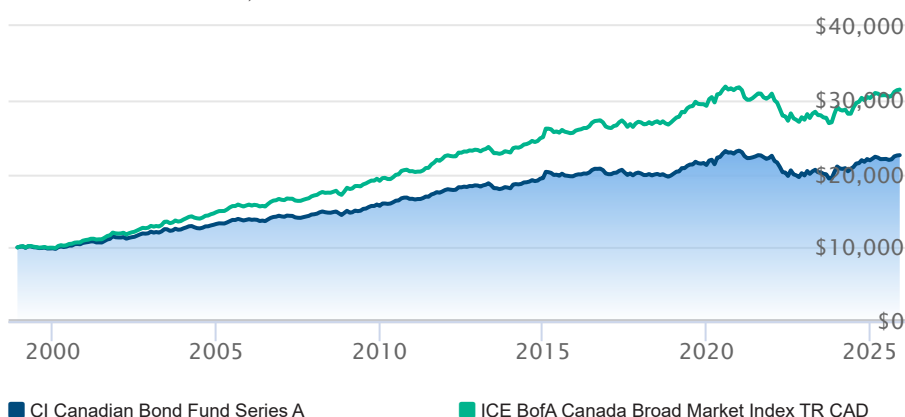
