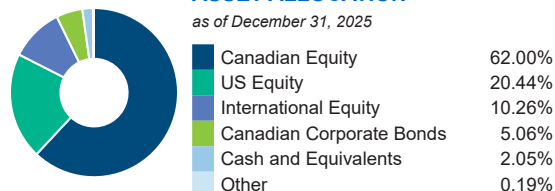

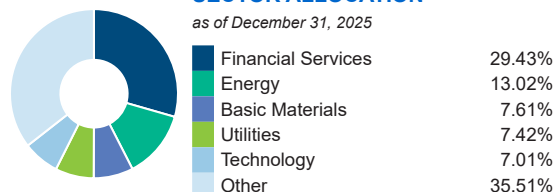
ASSET ALLOCATION
