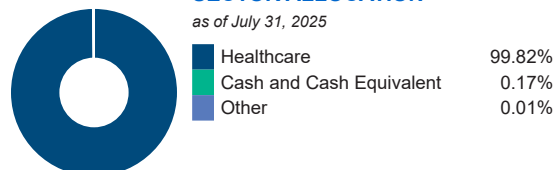
ASSET ALLOCATION

as of July 31, 2025



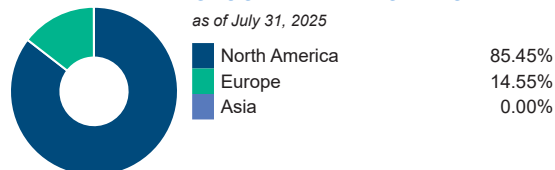
SECTOR ALLOCATION
