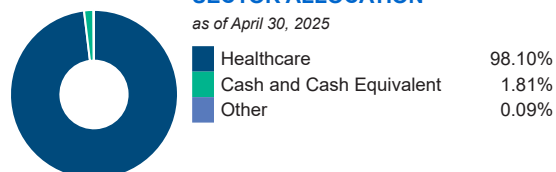
ASSET ALLOCATION

as of April 30, 2025



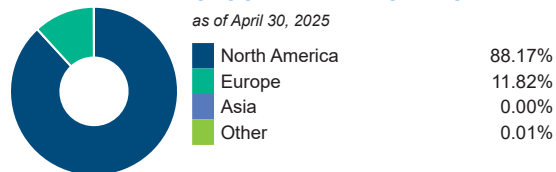
SECTOR ALLOCATION
