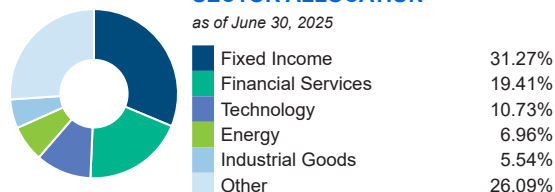
ASSET ALLOCATION

as of June 30, 2025



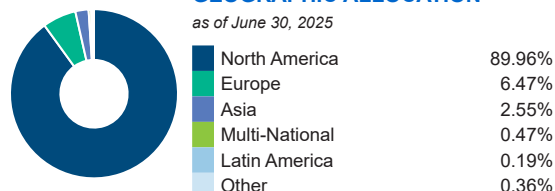
SECTOR ALLOCATION
