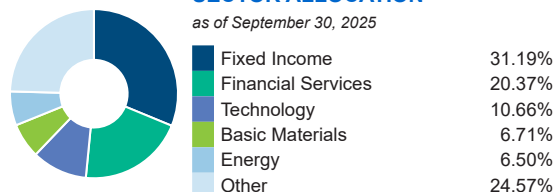
ASSET ALLOCATION
