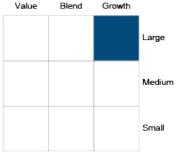


GEOGRAPHIC ALLOCATION

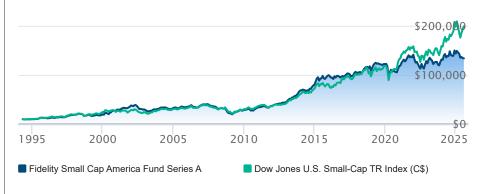
