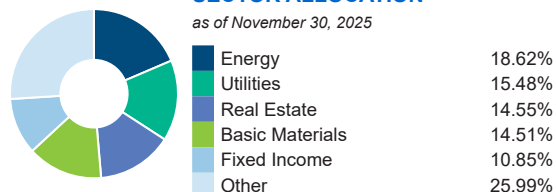
ASSET ALLOCATION

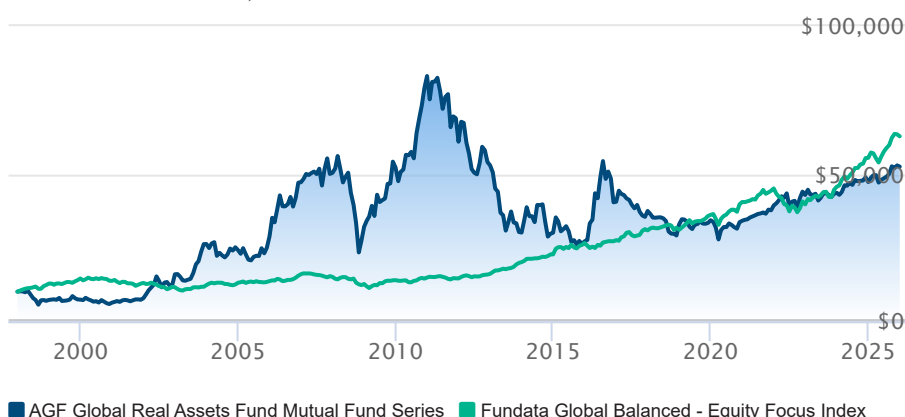
