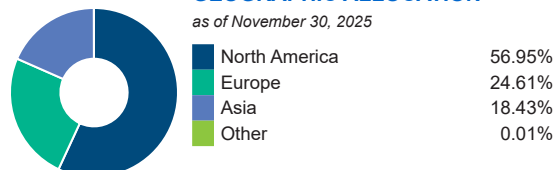
SECTOR ALLOCATION

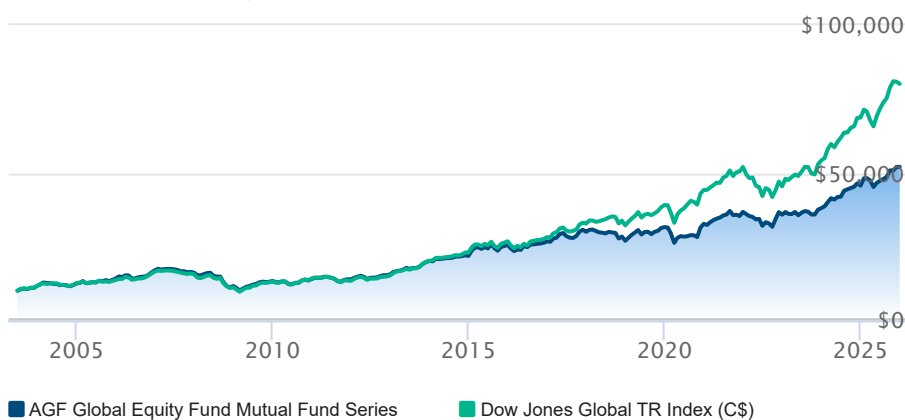
