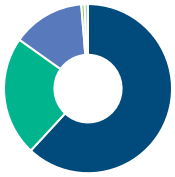

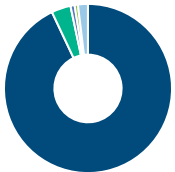

SECTOR ALLOCATION

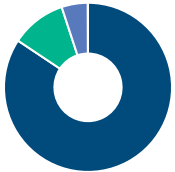
