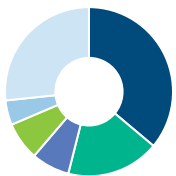

SECTOR ALLOCATION

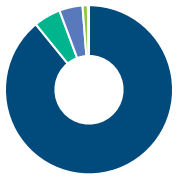
