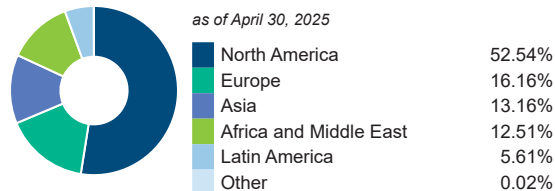
SECTOR ALLOCATION
