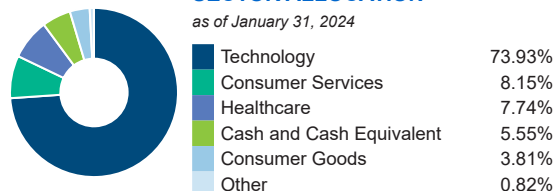
ASSET ALLOCATION

as of January 31, 2024



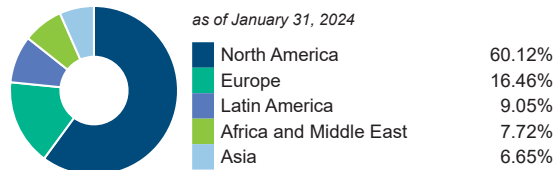
SECTOR ALLOCATION
