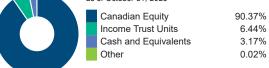

as of October 31, 2025



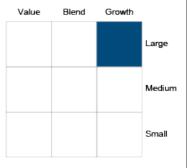
### **GEOGRAPHIC ALLOCATION**
