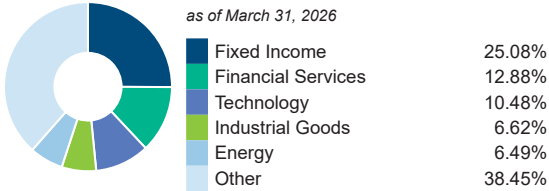
ASSET ALLOCATION

as of March 31, 2026



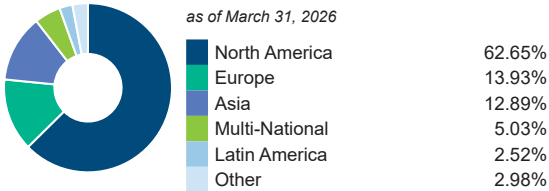
SECTOR ALLOCATION

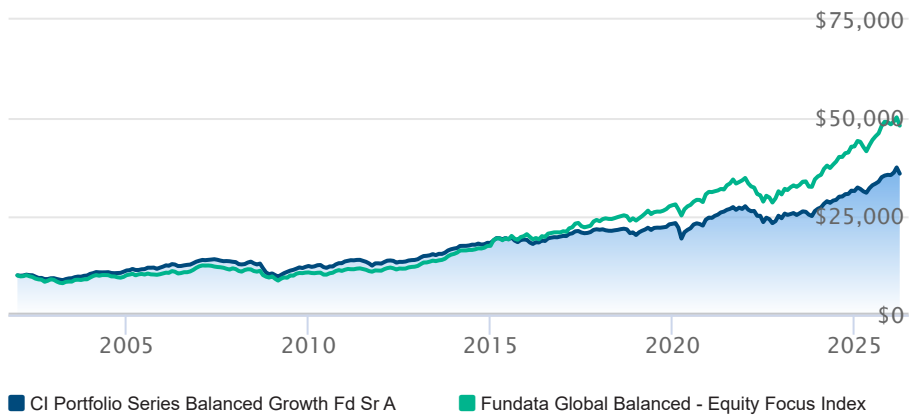
