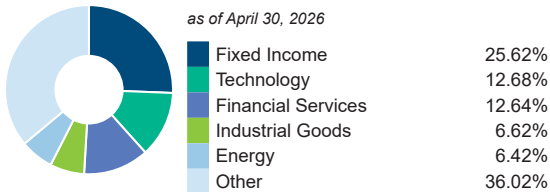
ASSET ALLOCATION

as of April 30, 2026



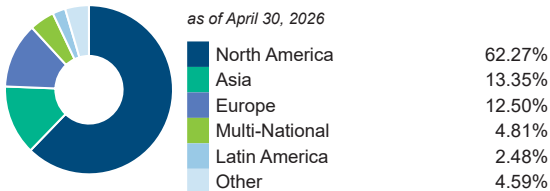
SECTOR ALLOCATION

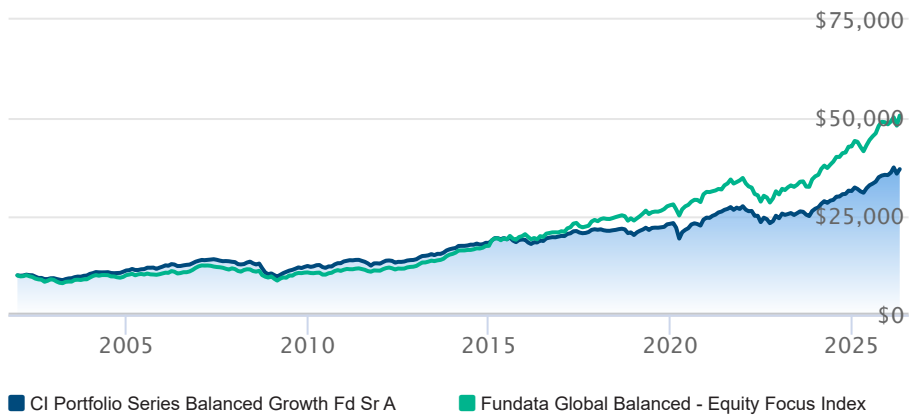
