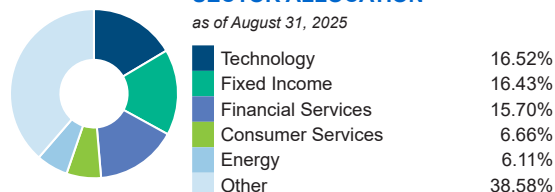
## ASSET ALLOCATION

as of August 31, 2025



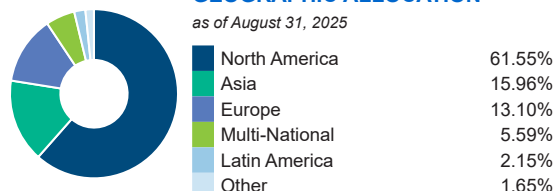
## SECTOR ALLOCATION

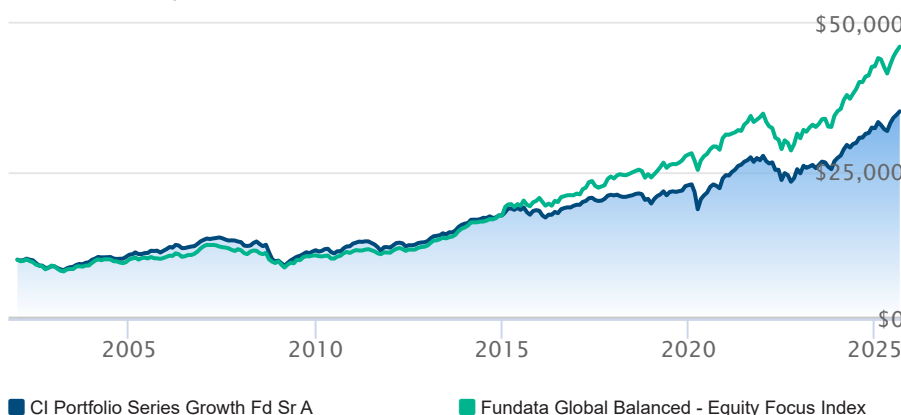
