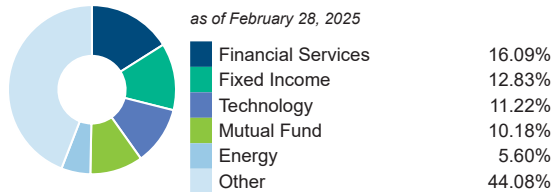
ASSET ALLOCATION

as of February 28, 2025



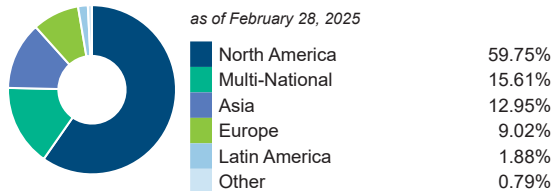
SECTOR ALLOCATION

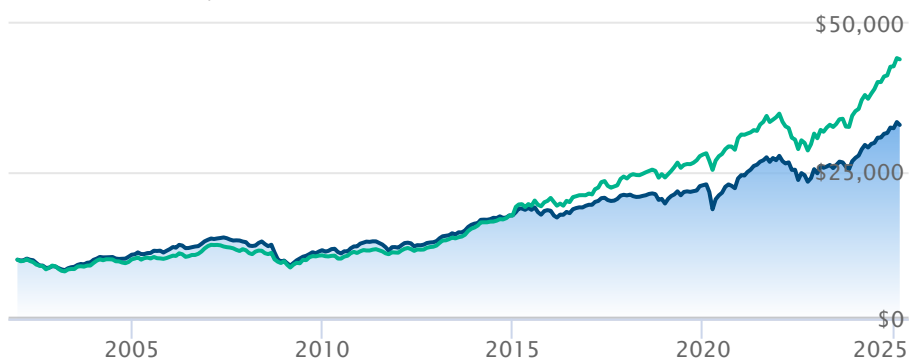
