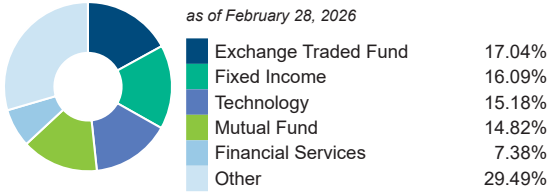
ASSET ALLOCATION

as of February 28, 2026



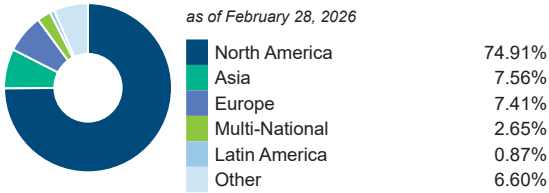
SECTOR ALLOCATION

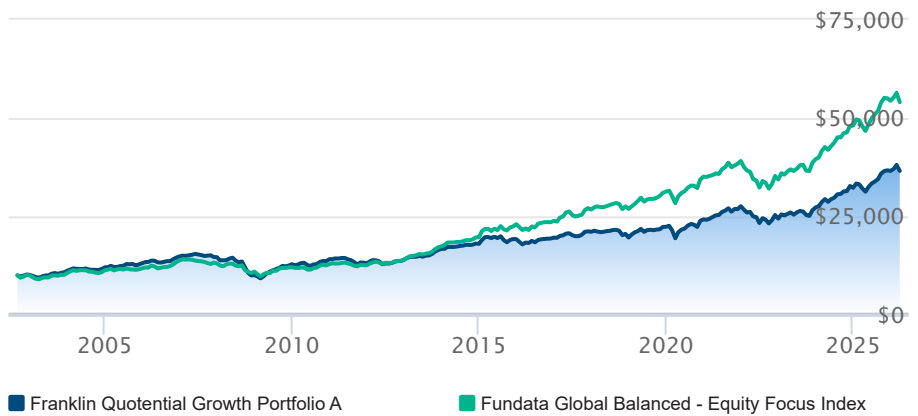
