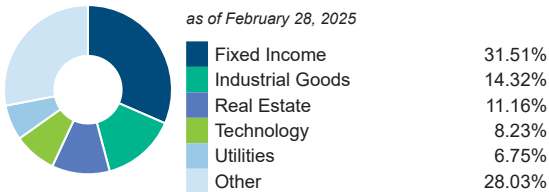
**ASSET ALLOCATION**

as of February 28, 2025



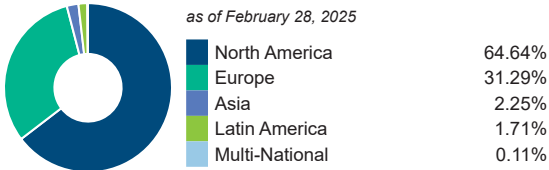
**SECTOR ALLOCATION**

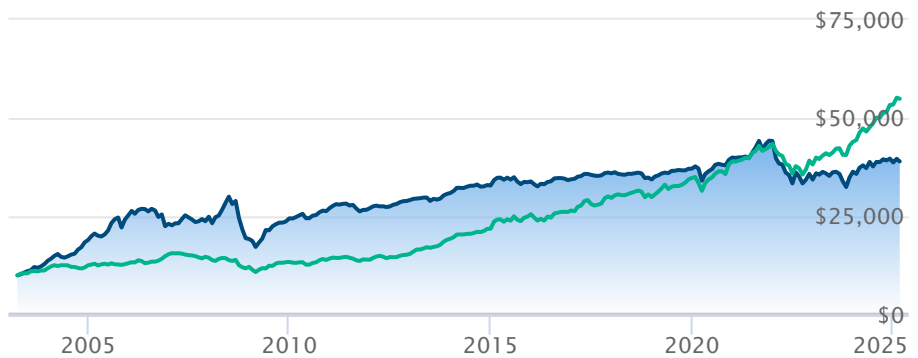
