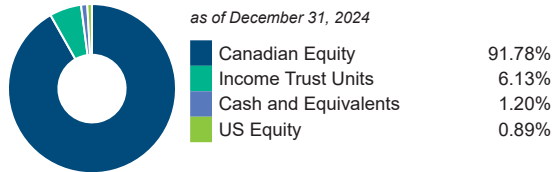

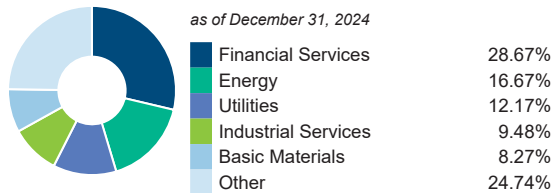
ASSET ALLOCATION

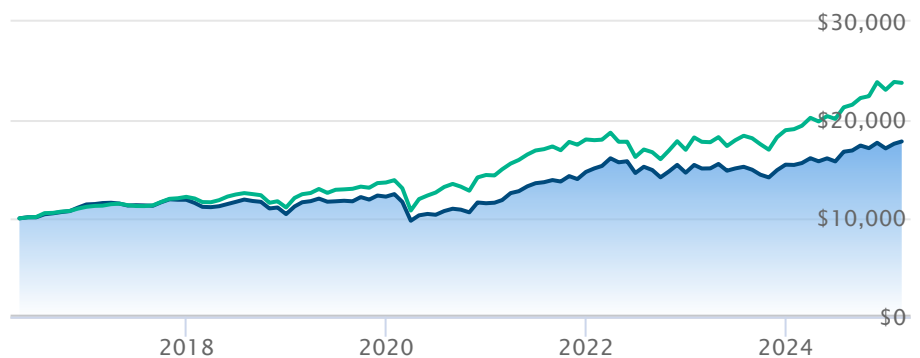
