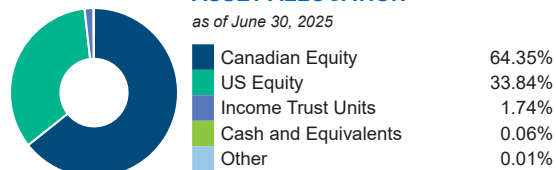

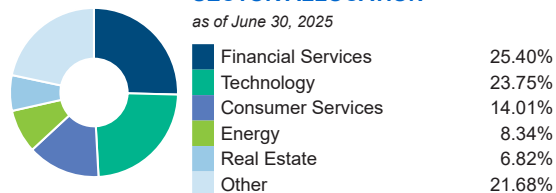
ASSET ALLOCATION

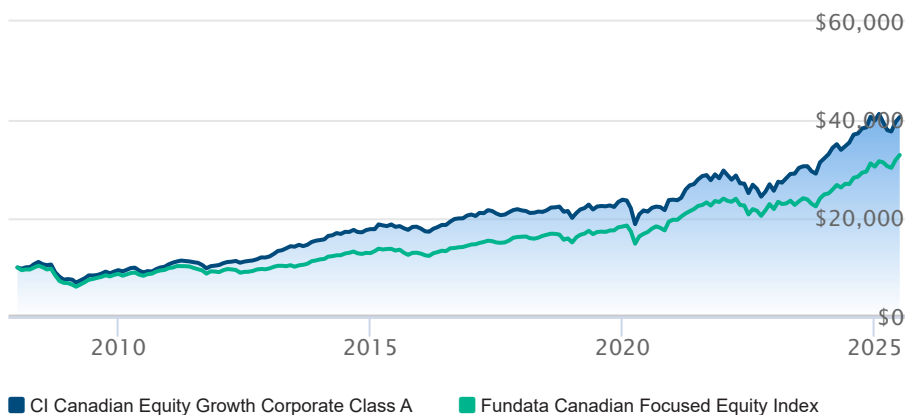
