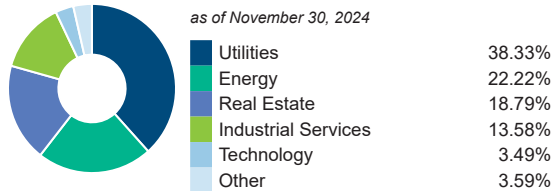
**ASSET ALLOCATION**

as of November 30, 2024



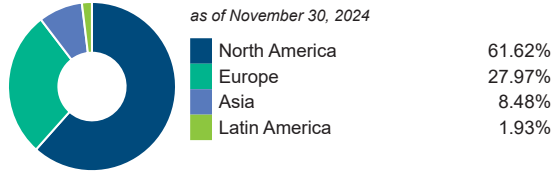
**SECTOR ALLOCATION**

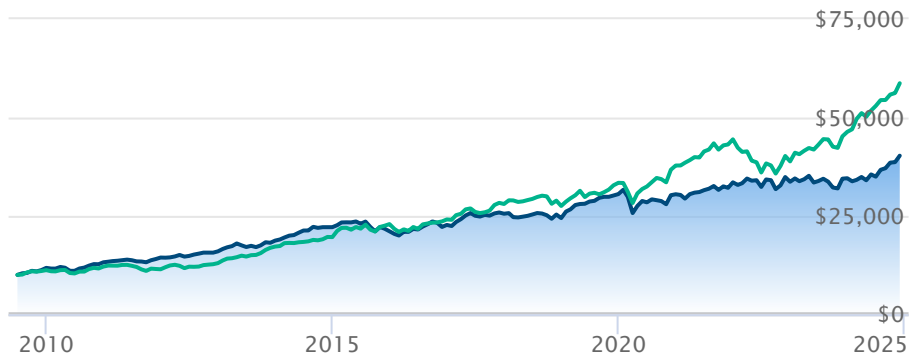
