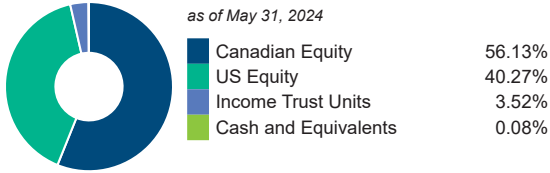

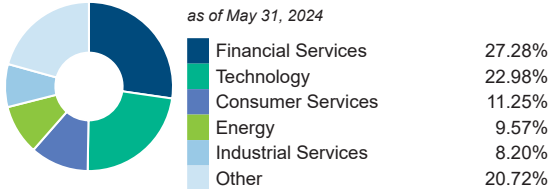
ASSET ALLOCATION

as of May 31, 2024



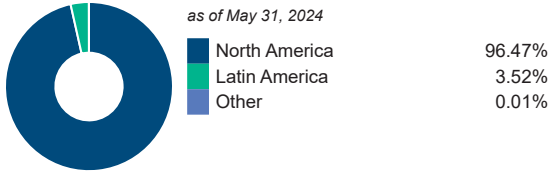
SECTOR ALLOCATION
