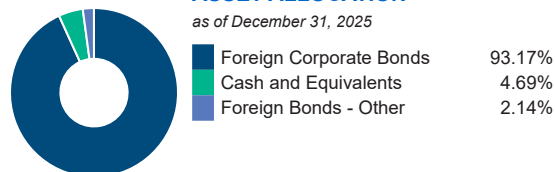

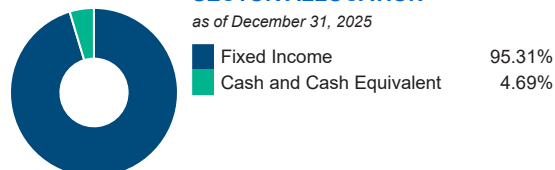
ASSET ALLOCATION

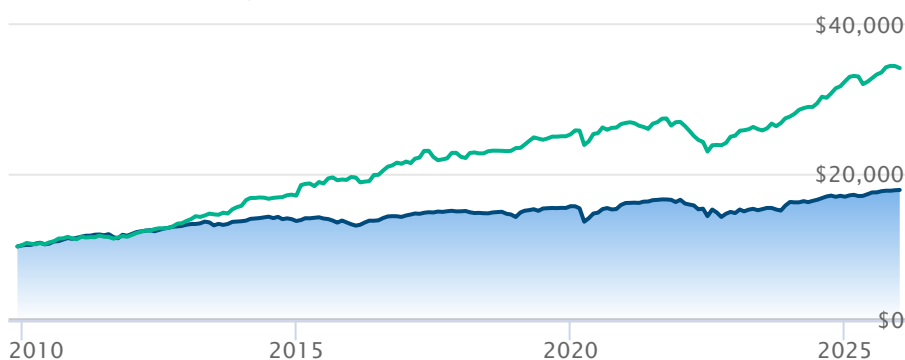
