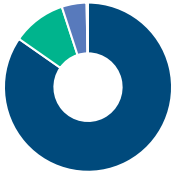

SECTOR ALLOCATION

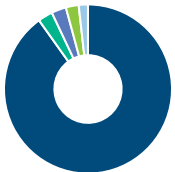
