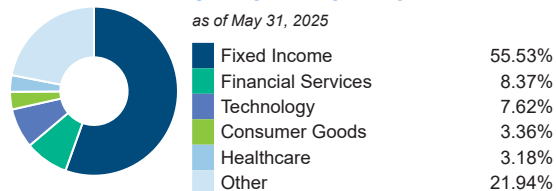
ASSET ALLOCATION
