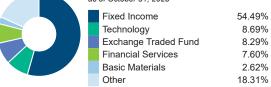

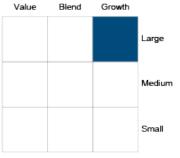


GEOGRAPHIC ALLOCATION

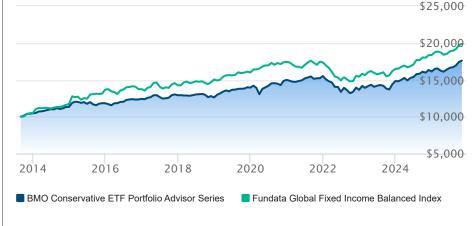
