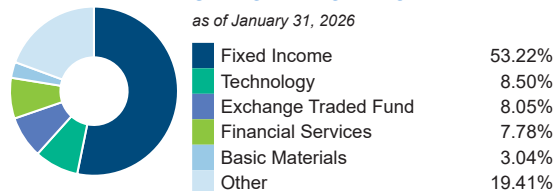
ASSET ALLOCATION

as of January 31, 2026



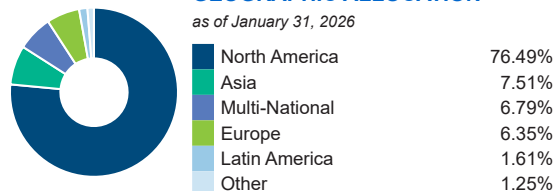
SECTOR ALLOCATION

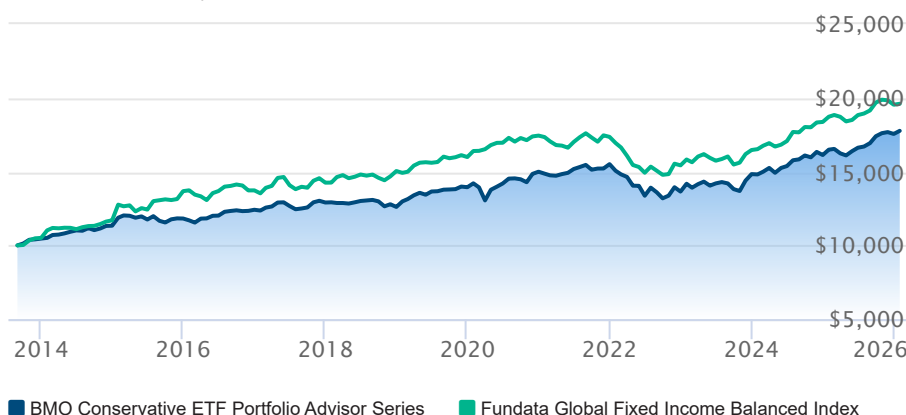
