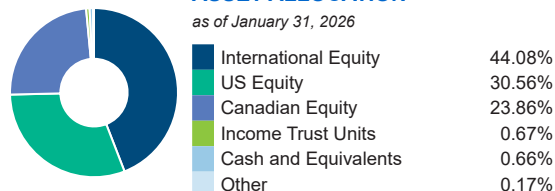

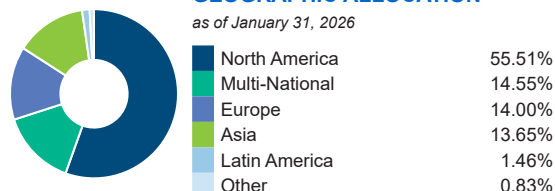
## SECTOR ALLOCATION

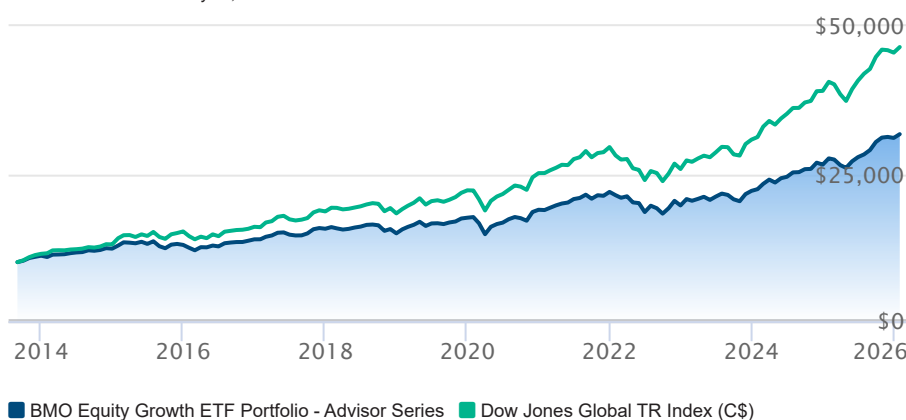
