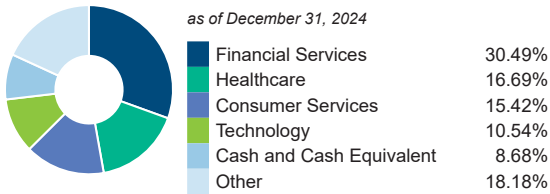
**ASSET ALLOCATION**

as of December 31, 2024



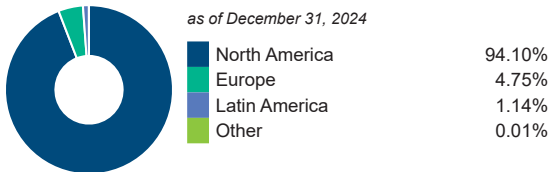
**SECTOR ALLOCATION**

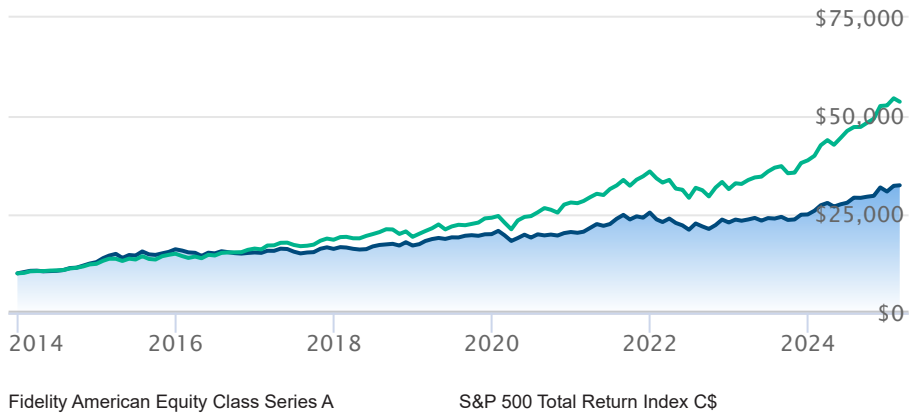
