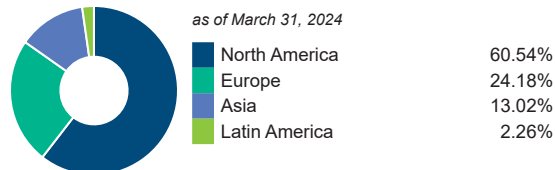
SECTOR ALLOCATION

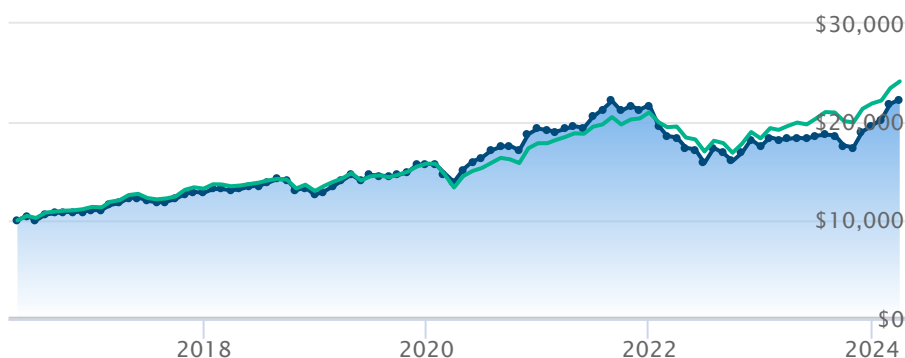
