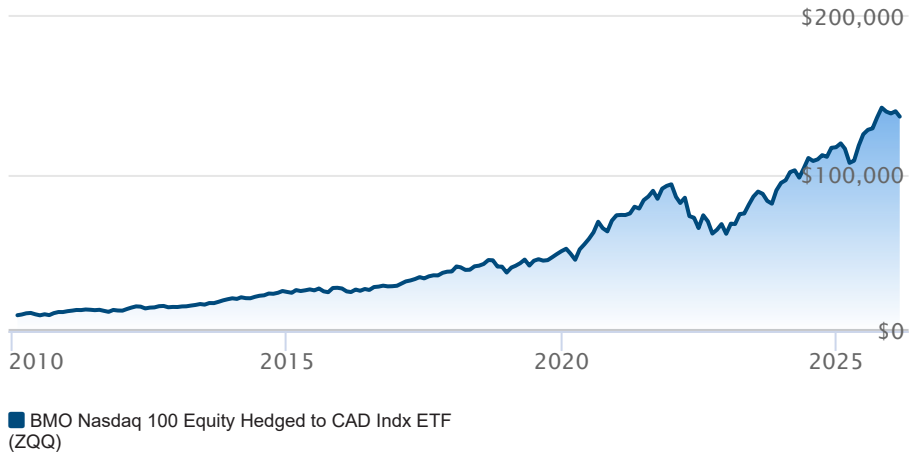

Annual values as of February 28, 2026



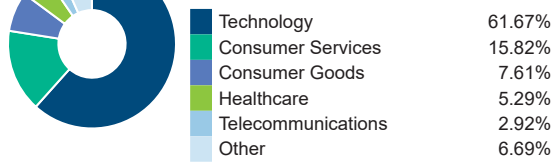
ASSET ALLOCATION
