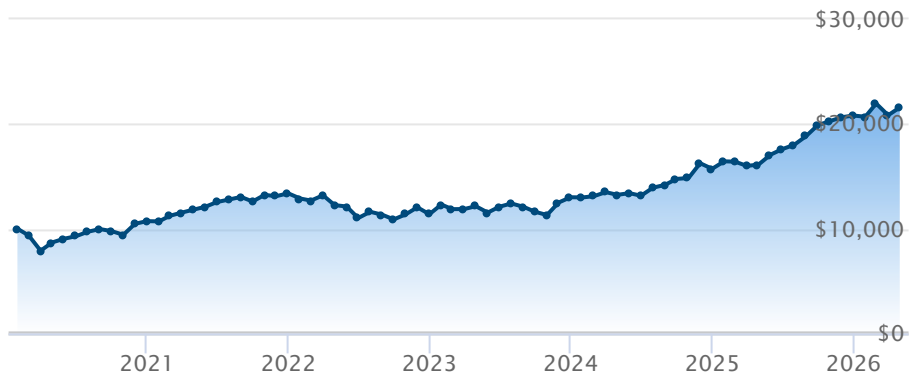

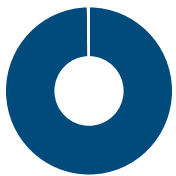
Annual values as of April 30, 2026
