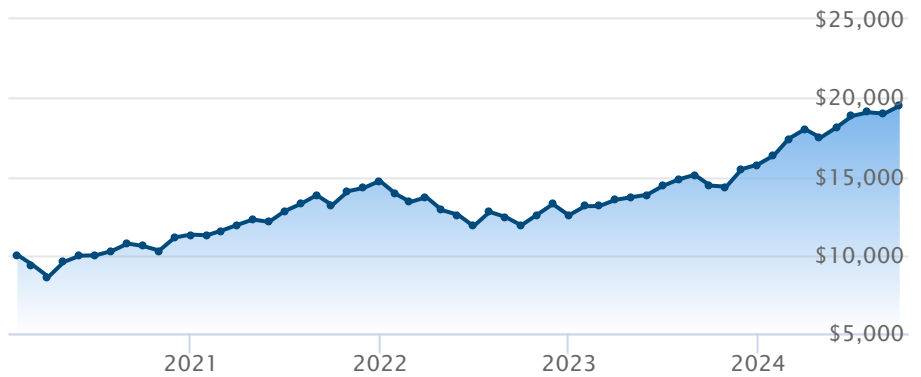

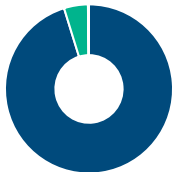
Annual values as of September 30, 2024

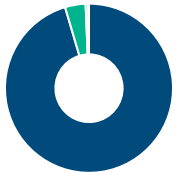
