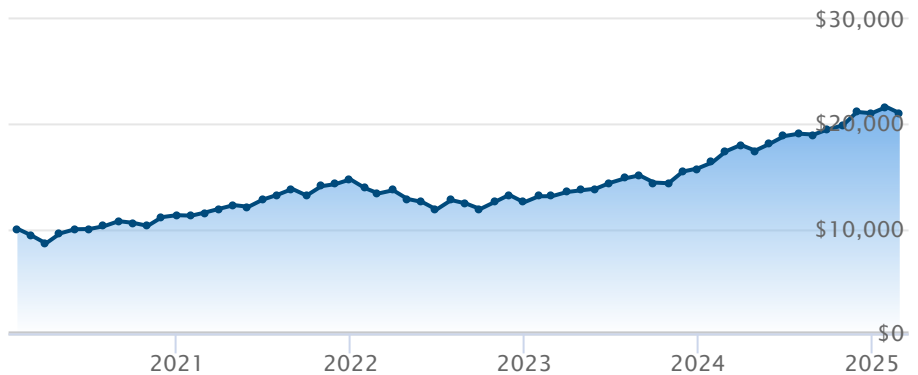

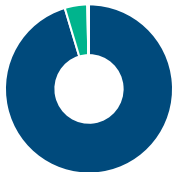
Annual values as of February 28, 2025

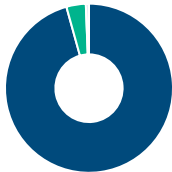
