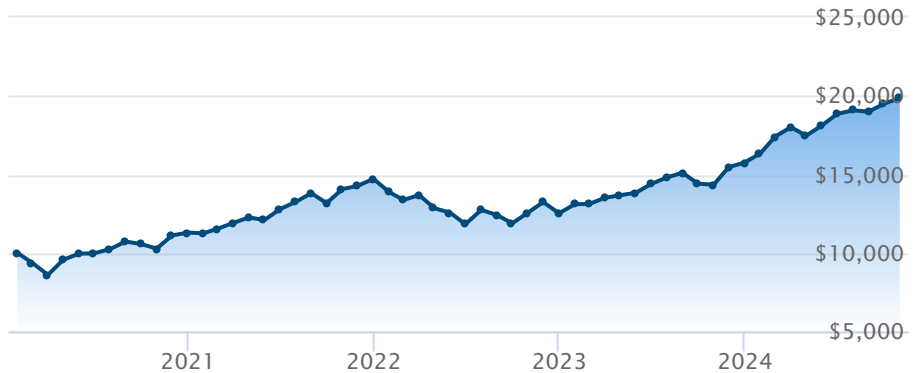

GROWTH OF \$10,000

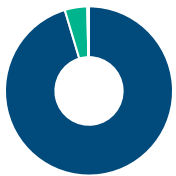
Annual values as of October 31, 2024

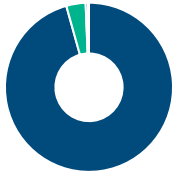
