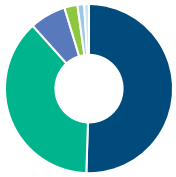

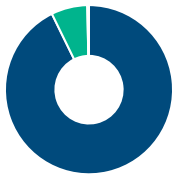

**SECTOR ALLOCATION**

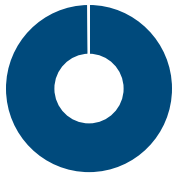

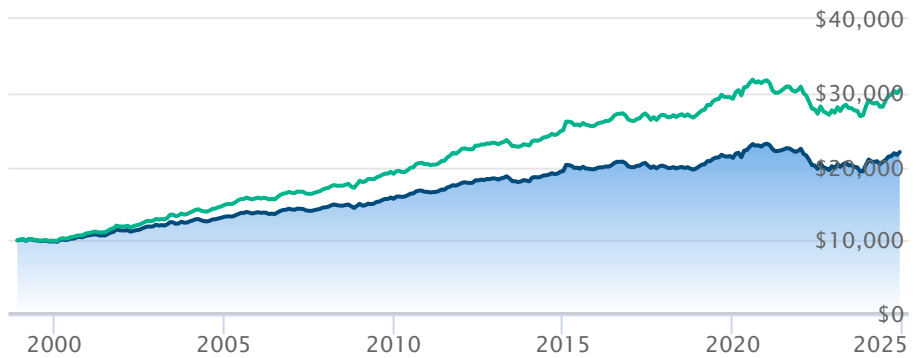
