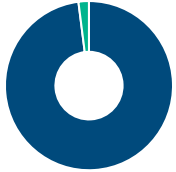

SECTOR ALLOCATION

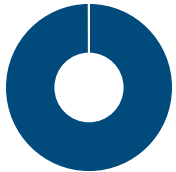

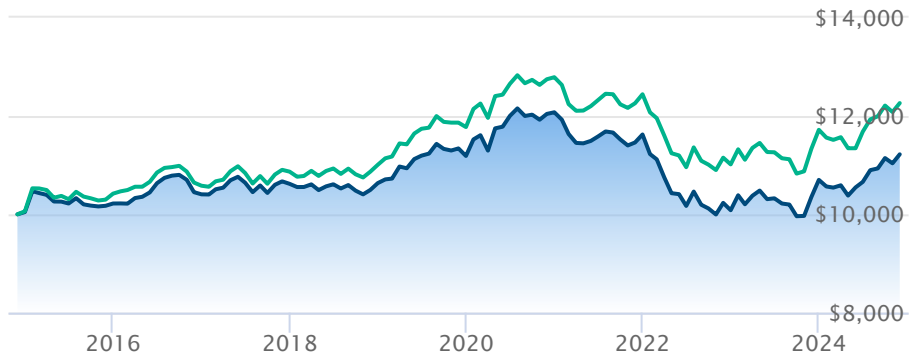
